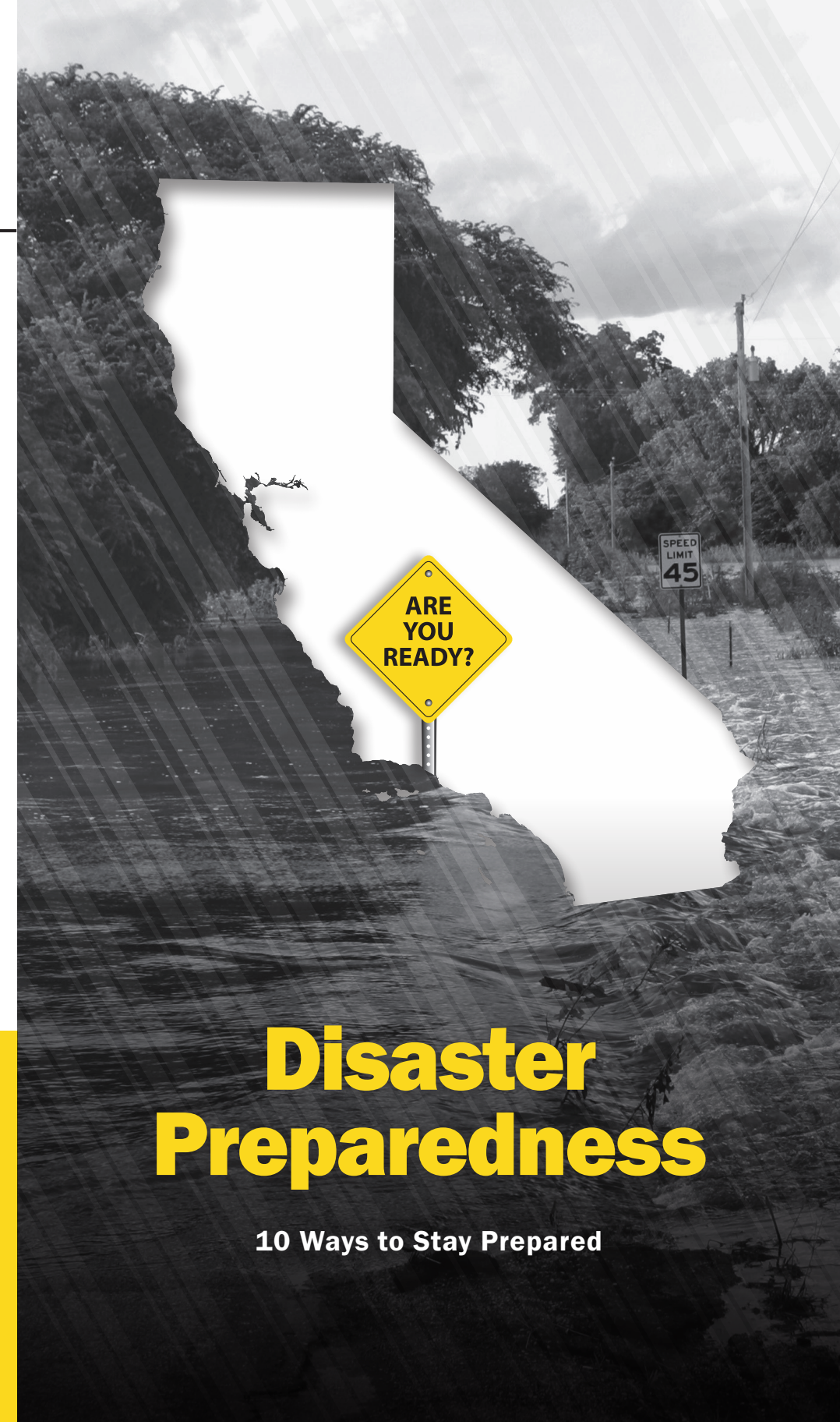

10 WAYS TO STAY PREPARED

Have a plan, know your risks.

- 1 Identify your risk.**
Find out what natural or human caused disasters pose a risk for you.
- 2 Create a family disaster plan.**
Your family needs a plan that tells everyone where to meet, who will be an out-of-state family contact, how to get emergency information and how to take care of your family pets. To start preparing today, go to [ready.gov](https://www.ready.gov).
- 3 Practice your disaster plan.**
Start by having family members meet at a designated spot outside your home.
- 4 Build a disaster supply kit and sign-up for notifications.**
Include a three-day supply of non-perishable food and water, first aid kit, tools and supplies, clothing and bedding, important documents, medications, and pet supplies. **Sign-up for real-time notices by texting your Zip Code to 888777.**
- 5 Prepare your children.**
Talk to them about the risks and plans that your family has if disaster strikes.
- 6 Don't forget the special needs of individuals in your household.**
Make sure that medical supplies for those with special needs are in your kit.
- 7 Learn CPR and first aid.**
Get trained on basic first aid and CPR; your training could save a life.
- 8 Eliminate hazards in your home and the workplace.**
Secure contents of your home or office to reduce hazards.
- 9 Understand that not all disasters are "natural."**
Disaster preparedness must now account for man-made disasters as well.
- 10 Get involved and volunteer.**
With proper training and education, civilian volunteers expand the resources available to states and local communities.

UNEMPLOYMENT INSURANCE:

Workers who lose their jobs due to no fault of their own, such as in the case of a disaster, may be eligible for Unemployment Insurance (UI) benefits. Eligibility for UI benefits requires that individuals be unemployed or working less than full time, be able to work, be seeking work, and be willing to accept a suitable job.

CA employers who are directly affected by a state of emergency may request up to a 60-day extension to file their state payroll reports and to deposit state payroll taxes with the Employment Development Department (EDD), without penalty or interest.
